**BYLAW NO. 03-18**

**A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF BARNWELL FOR THE 2018 TAXATION YEAR**

**WHEREAS**, the Village of Barnwell has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on April 19<sup>th</sup>, 2018

**WHEREAS**, the estimated municipal expenditures and transfers set out in the budget for the Village of Barnwell for 2017 total **\$1,505,383**; and

**WHEREAS**, the estimated municipal revenues and transfers from all sources other than property taxation is estimated at **\$1,004,568**; and the balance of **\$500,815** is to be raised by general municipal property taxation; and

**WHEREAS**, the requisitions are

Alberta School Foundation Fund (ASFF)	
- Residential/Farm land	\$ 186,483.92
- Non-residential	\$ 11,741.91
Holy Spirit RCSR	
- Residential/Farm land	\$ 6,464.58
- Non-residential	\$ 281.66

**WHEREAS**, the Council of the Village of Barnwell is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

**WHEREAS**, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2000; and

**WHEREAS**, the assessed value of all property in the Village of Barnwell as shown on the assessment roll is:

**NOW THEREFORE**, under the authority of the Municipal Government Act, the Council of the Village of Barnwell, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Barnwell:


