BYLAW NO. 1-18

**A BYLAW OF THE VILLAGE OF BARNWELL IN THE PROVINCE OF ALBERTA
TO ESTABLISH A MUNICIPAL EMERGENCY MANAGEMENT AGENCY**

WHEREAS the council of the Village of Barnwell is responsible for the direction and control of its emergency response and is required, under the Emergency Management Act, Chapter E-6.8, Revised Statutes of Alberta 2000, to appoint an Emergency Management Committee and to establish and maintain a Municipal Emergency Management Agency; and

WHEREAS it is desirable in the public interest, and in the interests of public safety, that such a committee be appointed and such an agency be established and maintained to carry out Council's statutory powers and obligations under the said Disaster Services Act;

NOW, THEREFORE the Council of the Village of Barnwell, duly assembled, enacts as follows:

1. This Bylaw may be cited as the Municipal Emergency Management Agency Bylaw.
2. In this Bylaw
 - a. "Act" means the Emergency Management Act, Chapter E-6.8, Revised Statutes of Alberta;
 - b. "Council" means the Council of the Village of Barnwell;
 - c. "disaster" means an event that has resulted or may result in serious harm to the safety, health or welfare of people, or in widespread damage to property;
 - d. "emergency" means a present or imminent event that requires prompt co-ordination of action or special regulation of persons or property to protect the health, safety or welfare of people or to limit damage to property;
 - e. "Emergency Management Committee" means the committee established under this Bylaw;
 - f. "Minister" means the Minister charged with administration of the Act;
 - g. "Municipal Emergency Management Agency" means the agency established under this Bylaw; and
 - h. "Municipal Emergency Plan" means the emergency plan prepared by the Director of Emergency Management to co-ordinate response to an emergency or disaster and includes the Intermunicipal Emergency Services plan adopted as part of the Regional

Emergency Management Framework Agreement with the Municipal
District of Taber and the Town of Vauxhall.

3. There is hereby established an Emergency Management Committee to advise Council on the development of emergency plans and programs.
4. There is hereby established a Municipal Emergency Management Agency to act as the agent of Council to carry out its statutory powers and obligations under the Act. This does not include the power to declare, renew, or terminate a state of local emergency, nor the powers contained in Section 12 of this Bylaw.
5. Council shall
 - a. by resolution, appoint its members to serve on the Emergency Management Committee;
 - b. provide for the payment of expenses of the members of the Emergency Management Committee;
 - c. by resolution, on the recommendation of the Emergency Management Committee, appoint a Director of Emergency Management and a Deputy Director of Emergency Management who shall do those things required of the Director of Emergency Management in that person's absence;
 - d. ensure that emergency plans and programs are prepared to address potential emergencies or disasters in the Village of Barnwell
 - e. approve the Village of Barnwell's emergency plans and programs; and
 - f. review the status of the Municipal Emergency Plan and related plans and programs at least once each year.
6. Council may
 - a. by Bylaw borrow, levy, appropriate and expend, without the consent of electors, all sums required for the operation of the Municipal Emergency Management Agency; and
 - b. enter into agreements with and make payments or grants, or both, to persons or organizations for the provision of services in the development or implementation of emergency plans or programs, including mutual aid plans and programs.
7. The Municipal Emergency Management Agency shall be comprised of one or more of the following:
 - a. Council;
 - b. the Director of Emergency Management;
 - c. the Deputy Director of Emergency Management;
 - d. the Administrator of the Village of Barnwell;

- e. the R.C.M. Police or designate;
- f. the Fire Chief or designate;
- g. the Public Information Officer or designate;
- h. the Public Works Foreman or designate;
- i. the Ambulance Service Manager or designate
- j. the Health Unit Manager or designate;
- k. the Hospital Director or designate;
- l. the School Board Chairman or designate
- m. the Social Services Manager or designate;
- n. representative(s) from adjacent communities which have entered into mutual aid agreements;
- o. representative(s) from local utility and telephone companies (Telus, Fortis, Atco);
- p. representatives from Canadian Pacific Railway;
- q. representatives from Alberta Emergency Management;
- r. representatives from Alberta Infrastructure and Transportation;
- s. representatives from Alberta Environment
- t. representatives from Alberta Municipal Affairs and Housing;
- u. any other individuals who Council deems necessary to mitigate an emergency

8. The Director of Emergency Management shall:

- a. prepare and co-ordinate the Municipal Emergency Plan and related plans and programs for the Village of Barnwell
- b. act as director of emergency operations, or ensure that someone is designated under the Municipal Emergency Plan to so act, on behalf of the Municipal Emergency Management Agency; and
- c. co-ordinate all emergency services and other resources used in an emergency; or
- d. ensure that someone is designated to discharge the responsibilities specified in paragraphs a, b, and c of this section.

9. The power to declare or renew a state of local emergency under the Act, the powers specified in Section 11 of this Bylaw, and the requirement specified in Section 14 of the Bylaw, are hereby delegated to any one of the following person(s):

- a. the Village of Barnwell Mayor, or
- b. the Village of Barnwell Deputy Mayor, or
- c. by resolution of the Village of Barnwell Council

when satisfied that an emergency exists or may exist in the Village of Barnwell.

10. When a state of local emergency is declared, the person making the declaration shall

- a. ensure that the declaration identifies the nature of the emergency and the area of the Village of Barnwell in which it exists;

- b. cause the details of the declaration to be published immediately by such means of communication considered most likely to notify the population of the area affected; and
- c. forward a copy of the declaration to the Minister forthwith.

11. Subject to Section 14, when a state of local emergency is declared, the person making the declaration may

- a. cause the Municipal Emergency Plan or any related plans or programs to be put into operation;
- b. acquire or utilize any real or personal property considered necessary to prevent, combat or alleviate the effects of an emergency or disaster;
- c. authorize or require any qualified person to render aid or a type he or she is qualified to provide;
- d. control or prohibit travel to or from any area of the Village of Barnwell;
- e. provide for the restoration of essential facilities and the distribution of essential supplies and provide, maintain and co-ordinate emergency medical, welfare and other essential services in any part of the Village of Barnwell;
- f. cause the evacuation of persons and the removal of livestock and personal property from any area of the Village of Barnwell that is or may be affected by a disaster and make arrangements for the adequate care and protection of those persons or livestock and of the personal property;
- g. authorize the entry into any building or on any land, without warrant, by any person in the course of implementing an emergency plan or program;
- h. cause the demolition or removal of any trees, structures or crops if the demolition or removal is necessary or appropriate in order to reach the scene of a disaster, or to attempt to forestall its occurrence or to combat its progress
- i. procure or fix prices for food, clothing, fuel, equipment, medical supplies, or other essential supplies and the use of any property, services, resources or equipment with the Village of Barnwell for the duration of the state of local emergency;
- j. authorize the conscription of persons needed to meet an emergency; and
- k. authorize any persons at any time to exercise, in the operation of the Municipal Emergency Plan and related plans or programs, any power specified in Paragraphs 'b' through 'j' in relation to any part of the municipality affected by a declaration of a state of local emergency.

12. When a state of local emergency is declared,

- a. neither Council nor any member of Council, and
- b. no person appointed by Council to carry out measures relating to emergencies or disasters,

is liable in respect of damage caused through any action taken under this Bylaw, nor are they subject to any proceedings by prohibition, certiorari, mandamus or injunction.

13. Notwithstanding Section 12,

- a. Council and any member of Council, and
 - b. any person acting under the direction or authorization of Council,
- is liable for gross negligence in carrying out their duties under this Bylaw.

14. When in the opinion of the person or persons in Village of Barnwell Council declaring the state of local emergency, an emergency no longer exists in relation to which the declaration was made, they shall, by resolution, terminate the declaration.

15. A declaration of a state of local emergency is considered terminated and ceases to be of any force or effect when

- a. a resolution is passed under Section 14;
- b. a period of seven days has lapsed since it was declared, unless it is renewed by resolution;
- c. the Lieutenant Governor in Council makes an order for a state of emergency under the Act, relating to the same area; or
- d. the Minister cancels the state of local emergency.

16. When a declaration of a state of local emergency has been terminated, the person who made the declaration shall cause the details of the termination to be published immediately by such means of communication considered most likely to notify the population of the area affected.

17. The Village of Barnwell Council may co-operate with Councils of other municipalities for the purpose of jointly establishing and operating a Municipal Emergency Response Organization and upon appropriate agreement, enter into a Mutual Aid Agreement.

18. Bylaw No. 1-08 passed on January 17, 2008 and all amendments thereto are hereby rescinded.


This Bylaw comes into force and effect upon the date of the third and final reading.
