BYLAW NO. 2-08

BEING A BYLAW OF THE VILLAGE OF BARNWELL IN THE PROVINCE OF ALBERTA, TO AMEND BYLAW NO. 1-97, BEING THE MUNICIPAL LAND USE BYLAW.

WHEREAS the Council has annexed several parcels of land into its boundary and are desirious to establish the zoning of these parcels under the Village of Barnwell Land Use Bylaw No. 1-97;

AND WHEREAS the Council is in receipt of a request to redesignate lands within the Village boundary to accommodate future residential development;

AND WHEREAS Council recognizes the zoning will allow the owners of these parcels to continue their current use(s) or accommodate future development;

AND WHEREAS THE PURPOSE of the proposed Bylaw No. 2-08 is redesignate the land, recently annexed into the Village of Barnwell from the current zoning under the Municipal District of Taber Land Use Bylaw No. 1722, legally described as:

Block 56, Plan 5841 EG	from Rural Urban Fringe – R/UF to Agricultural - A

And those lands previously within the Village boundary legally described as:

Those portions of Blocks 47 and 48 which lies west of subdivision plan 983LK, Plan 5841 EG from Agricutitural – A to Residential – R;

AND WHEREAS the said lands are illustrated on the map in Schedule A attached hereto.

AND WHEREAS the municipality must prepare an amending bylaw and provide for its consideration at a public hearing.

NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, the Council of the Village of Barnwell, in the Province of Alberta, duly assembled does hereby enact the following:

- Lands legally described above and illustrated on the map in Schedule A attached hereto shall be redesignated as prescribed.
- 2. Bylaw No. 1-97, being the Land Use Bylaw, is hereby amended.
- 3. This bylaw shall come into effect upon third and final reading hereof.
