- updating and establishing standards and procedures regarding the use and development of land within the municipality;
- incorporating new development standards for uses within the Village;
- · incorporate and designate lands recently annexed to the Village;
- to amend the existing Land Use District Map to reflect land use redesignations and new districts; and
- to comply with the provisions of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended.

AND WHEREAS the purpose of proposed Bylaw No 2-09 is to foster orderly growth and development in the Village;

AND WHEREAS, a public hearing was conducted in accordance with Section 692 of the Act;

- 1. Bylaw No.1-97, being the former Land Use Bylaw, and any amendments thereto, is hereby rescinded.
- 2. Bylaw No. 2-09 shall come into effect upon third and final reading thereof.
- 3. Bylaw No. 2-09 is hereby adopted.

- Section 29 (1) (b) should be changed to read "development shall not commence until at least 14 days from the date of receipt of the notice"
- Changes to Schedule 2: Residential R Land Use District
 - Section 3 Minimum Setback Requirements add additional side setback of 10 feet to each use listed.
- Changes to Schedule 2: Residential Manufactured Home RMH Land Use District
 - o Add mobile home and modular home as permitted uses
- Changes to Schedule 6: Moved-in Building Standards
 - o The "shall" in section 5 should be amended to read "may"
- Changes to Schedule 7: Development Standards for Manufactured, Mobile, Modular and Ready to Move homes
 - o Part B: in the two definitions the reference to "basement" should be amended to read "basement/slab"
 - Section1 (b) the reference to "basement" should be amended to read "basement/slab"
