BEING a bylaw of the Village of Barnwell in the Province of Alberta, to amend Bylaw No. 2-09, being the municipal Land Use Bylaw.

WHEREAS the Village Council is in receipt of an application for a Land Use Bylaw Amendment to redesignate lands within the municipality as shown on the map in Schedule 'A' attached hereto and legally described as:

**PORTION OF LOT 13, BLOCK1, PLAN 071 3622 WITHIN THE NORTHWEST  
QUARTER OF SECTION 21 TOWNSHIP 9 RANGE 17 WEST OF THE 4<sup>TH</sup> MERIDIAN**

AND WHEREAS the purpose of proposed Bylaw No. 2-12 is redesignate the above-noted lands from "Residential - R" to "General Commercial - GC" to accommodate the future development of billboard signs.

AND WHEREAS the municipality must prepare an amending bylaw and provide for its consideration at a public hearing.

NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, Statutes of Alberta, Chapter M-26, 2000, as amended, the Council of the Village of Barnwell in the Province of Alberta duly assembled does hereby enact the following:

1. Lands, illustrated on the map in Schedule 'A' and legally described above, shall be redesignated and the Land Use District Map found in Schedule 1 shall be amended to reflect this redesignation.
3. Bylaw No. 2-09 is hereby amended.
4. This bylaw shall come into effect upon third and final reading hereof.
5. That Bylaw 2-09 be consolidated to include Bylaw 02-12.

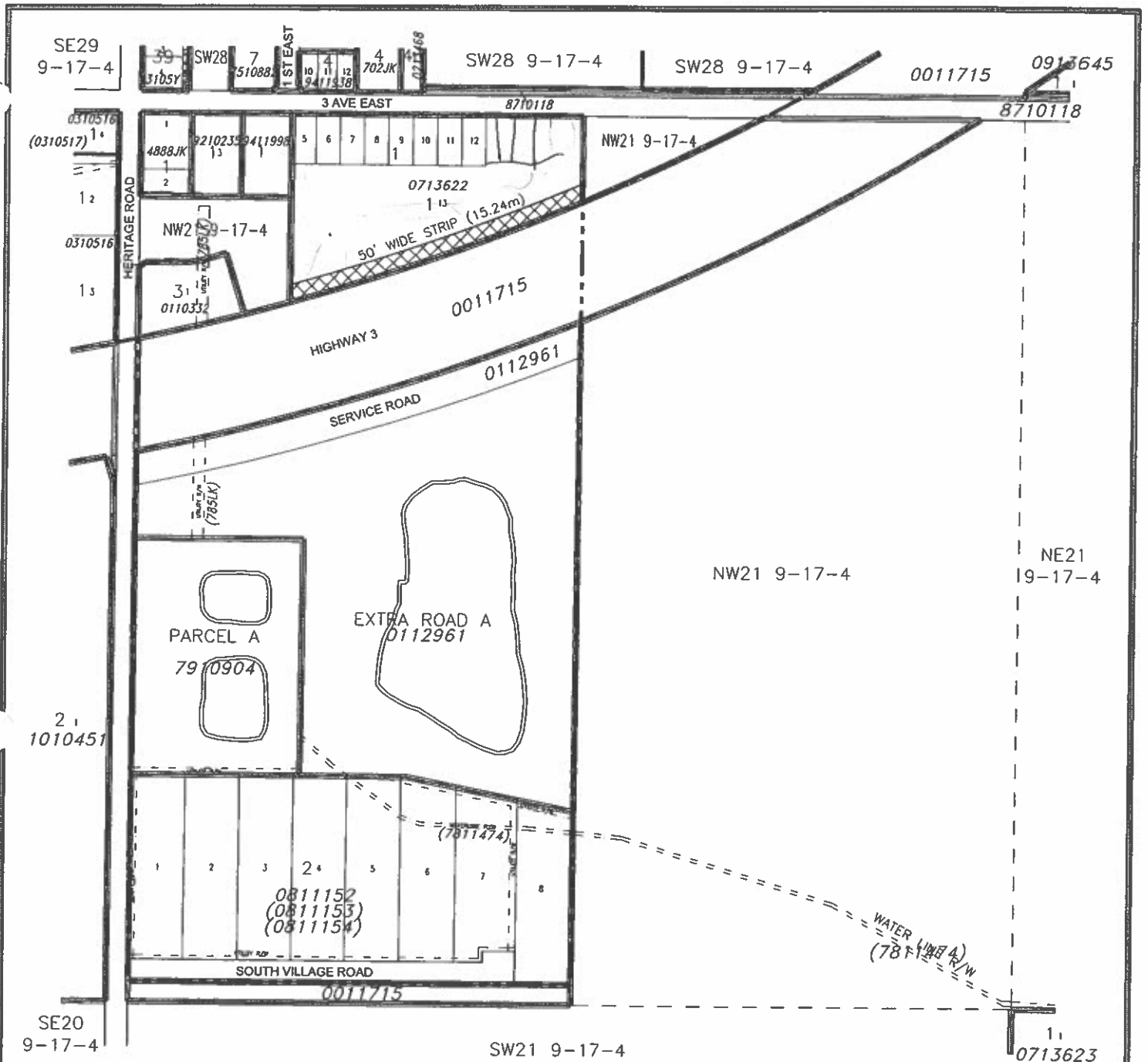
