# CORPORATION OF THE VILLAGE OF BARNWELL IN THE PROVINCE OF ALBERTA

#### **BYLAW NO. 3-03**

A BYLAW OF THE VILLAGE OF BARNWELL IN THE PROVINCE OF ALBERTA TO AMEND BYLAW NO. 7-90 AND BYLAW NO. 2-02 WHICH PROVIDES FOR THE LICENSING AND CONTROL OF DOGS AND RESTRICTED DOGS RESPECTIVELY WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF BARNWELL.

WHEREAS the Council of the Village of Barnwell, in the Province of Alberta, duly assembled, may pass a Bylaw and or regulations pursuant to Section 7 of the Municipal Government Act, being Chapter M-26.1, Statutes of Alberta, and any amendments thereto:

NOW, THEREFORE, the Council of the Village of Barnwell, in the Province of Alberta duly assembled enacts as follows:

### SECTION I AMENDMENTS

1.1 Bylaw No. 7-90, Section 18 (a) and Bylaw No. 2-02, Section 7.1 are hereby amended to read:

"Where an Animal Control Officer, Peace Officer or other person authorized to carry out the provisions of the Bylaw believes that a person has contravened any provision of this Bylaw, they may serve upon such person a notice of form commonly called a Bylaw Ticket, having printed wording approved by the Village Administrator, in the form similar, but not limited to, Schedule "A" which is attached to and forming part of this bylaw."

**1.2** Bylaw No. 2-02, Section 8.1 is hereby amended to read:

"A person who contravenes a provision of the Bylaw by doing something which he/she is prohibited from doing, or by failing to do something which he/she is required to do, or by doing something in a manner different from that in which he/she is required or permitted to do in the Bylaw, is guilty of an offense and liable to, upon summary conviction, a fine of not more than two thousand five hundred (\$2500.00) dollars and not less than five hundred (\$500.00) dollars, per infraction and upon failure to pay said fine and costs, to imprisonment for a period not exceeding thirty (30) days, per infraction."

## VILLAGE OF BARNWELL BYLAW NO. 3-03 cont.

### SECTION II COUNCIL INTENT

2.1 It is the intention of the Council of the Village of Barnwell, that each separate provision of this Bylaw shall be deemed independent of all other provisions herein and it is further the intention of Council that if any provision of this Bylaw be declared invalid, all other provisions thereof shall remain valid and enforceable.

### **SECTION III EFFECTIVE DATE**

3.1 This Bylaw shall come into force and effect upon the final passing thereof.
