BEING a bylaw of the Village of Barnwell in the Province of Alberta, to amend Bylaw No. 2-09, being the municipal Land Use Bylaw.

WHEREAS the Village Council is in receipt of an application for a Land Use Bylaw Amendment to redesignate lands within the municipality as shown on the map in Schedule 'A' attached hereto and legally described as:

LOTS 4 TO 7, BLOCK 62, PLAN 5841 EG LOCATED IN THE

AND WHEREAS the purpose of proposed Bylaw No. 3-10 is to redesignate the above-noted lands from "General Commercial - GC" to "Residential - R" to accommodate the future development of residential uses.

AND WHEREAS the municipality must prepare an amending bylaw and provide for its consideration at a public hearing.

NOW THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, Statutes of Alberta, Chapter M-26, 2000, as amended, the Council of the Village of Barnwell in the Province of Alberta duly assembled does hereby enact the following:

1. Lands, illustrated on the map in Schedule 'A' and legally described above shall be redesignated.
2. The Land Use District Map shall be amended to reflect this redesignation.
3. Bylaw No. 2-09 is hereby amended.
4. This bylaw shall come into effect upon third and final reading hereof.

READ a first time this 19th day of August, 2010.

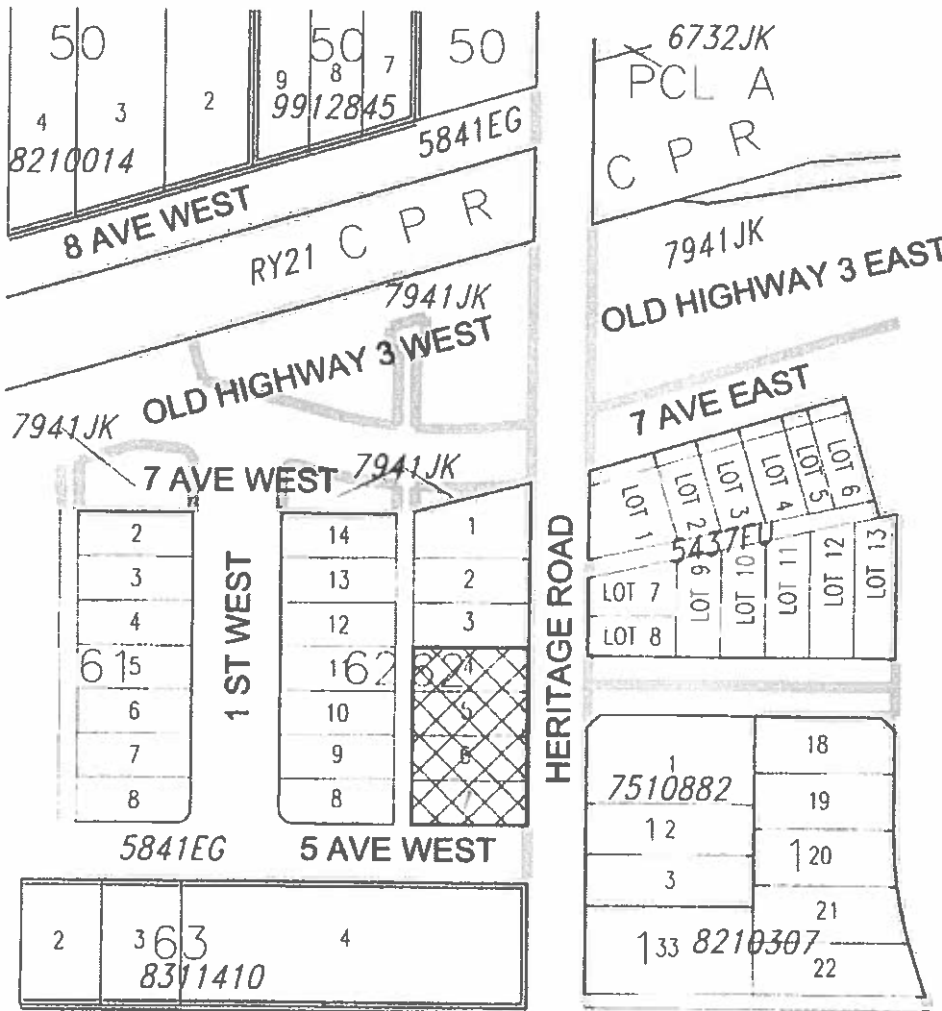
