Policy Statement and Guidelines

A. The following is a schedule of Fees for specified services provided by the Village of Barnwell effective the date of approval by resolution of council.

1. Development Permit Fees
 - a. Dwelling Structures up to 3 units \$50.00
 - Dwelling Structures 4 or more units \$75.00
 - Additions to Dwellings \$25.00
 - b. Commercial and Industrial Structures \$100.00

2. Land-Use Bylaw Amendments
 - a. Amendment Fee \$50.00
 - b. Notification Fee \$50.00
 - c. Advertising \$100.00

3. Discretionary Uses and Home Occupations
 - a. Notification Fee \$75.00
 - b. Advertising \$75.00

4. Letters of Compliance \$20.00

5. Special Meeting Fee \$100.00

6. Tax Certificates \$20.00

7. Land Use By-Law \$5.00

8. Annual Financial Statement \$5.00

9. Photocopies
 - a. Photocopy as is (per copy) \$0.10
 - b. Reduction/Enlargements (per copy) \$0.15

10. Faxes
 - a. Local or Toll Free \$1.00
 - b. Long Distance \$2.00

11. Complaints to Assessment Review Board (per roll) \$20.00
(Refundable if Complaint Justified)



12. Village Maps (per copy) \$0.25
13. Search Request and Other Services
- a. All request for information other than as specified above shall be accompanied by a written request as well as a non-refundable processing fee of \$15.00 per hour.
 - b. In the event the information requested requires an archival search, there will be an additional non-refundable processing fee of \$20.00.
14. Bulk Water Purchases from Back flow reservoir \$500.00
(per oil well)



In this Policy


(a) **"Council Chambers"** means the room situated on the north of the Barnwell Public Library building located at 490 Cottonwood Street.


Council Chambers of the Village of Barnwell may only be used for the following:
